ORDER

This Writ Petition has been filed to direct the respondent to give permission and police protection to conduct cultural programme (Adal Padal Nigalchi) in the event of Mallappalli Village Arulmigu Sree Mariyamman Temple Festival at Natrampalli Taluk, Tirupathur District on 18.05.2023 between 06.00 P.M to 11.00 P.M by considering the petitioner's representation dated 03.04.2023.
