2. The learned counsel appearing for the petitioner submitted that in order to conduct the cultural programme in the event of ***"Sri Gundi Mariamman Temple Festival" Pethakallupalli Village, Thekkupattu Post,***

Therefore, in view of the detailed circular and guidelines issued by the Director General of Police, the respondent police is hereby directed to consider the representation
