ORDER

This Writ Petition has been filed to direct the respondent to give permission to conduct cultural programme (Adal Padal Nigalchi) in the event of Edachithur Village Arulmigu Sree Manmathan Swamy Temple Festival at Virudhachalam Taluk, Cuddalore District on 04.05.2023 between 06.00 PM to 11.00 PM by considering the petitioner's representation dated 05.04.2023.

Therefore, in view of the detailed circular and guidelines issued by the Director General of Police, the respondent police is hereby directed to consider the representation of the petitioner, dated **05.04.2023** and pass suitable orders based on the above said circular.
