The Writ Petition has been filed to direct the first and second respondents to grant permission to conduct the cultural programme of Adal Padal on 03.05.2023 at 06.00 PM to 11.00 PM at "Sri Ponniamman Temple Festival" Echangadu Village, Poigamottur Post, Anaicut Taluk, Vellore District based on the representation dated 31.03.2023 made by the petitioner.

2.The learned counsel appearing for the petitioner submitted that in order to conduct the cultural programme in the event of "Sri Ponniamman Temple Festival" Echangadu Village, Poigamottur Post, Anaicut Taluk, Vellore District on 03.05.2023 between 6 PM to 11 PM, the petitioner has sent a representation dated 31.03.2023 to the respondent. But, the same has not been considered so far. Hence, the present writ petition has been filed.

3.The learned Government Advocate (Crl.side) appearing for the respondent submitted that the respondent police has received the representation of the petitioner and the same is pending for consideration.

Therefore, in view of the detailed circular and guidelines issued by the Director General of Police, the respondent police is hereby directed to consider the representation of the petitioner, dated 03.05.2023 and pass suitable orders based on the above said circular.

6. With the above direction, this Writ Petition is disposed of. No costs.
