Therefore, nothing survives in these writ petitions as well as the criminal original petition for adjudication.

3. Recording the said submission, the Writ Petitions and the Criminal Original Petition are closed. Consequently, connected Miscellaneous Petition is closed. There shall be no orders as to costs in respect of the Writ Petitions.
