2. When the matter is taken up for hearing today, the learned counsel for the petitioner submitted that above writ petition has been filed challenging the

suspension order dated 20.12.2022, in which, the respondent-Institute suspended the petitioner from pursuing his studies in view of the summon received from the Inspector of Police, F1, Kottakuppam Police Station, Villupuram District regarding the alleged involvement of the petitioner in Crime No.390 of 2022 registered under Section 8(c), 20(b)(ii)(d) of the NDPS Act. However, during the pendency of the writ petition, the suspension order passed against the petitioner has been revoked and he was permitted to continue his studies.
