ORDER

This Writ Petition has been filed to direct the respondent to give permission to conduct cultural programme (Adal Padal Nigalchi) in the event of Bargur, Durais Nagar Arulmigu Sree Kongu Nattu Mariyamman Temple Festival at Bargur Taluk, Krishnagiri District on 03.05.2023 between 06.00 PM to 11.00 PM by considering the petitioner's representation dated 08.04.2023.

Therefore, in view of the detailed circular and guidelines issued by the Director General of Police, the respondent police is hereby directed to consider the representation of the petitioner, dated **08.04.2023** and pass suitable orders based on the above said circular.
