ORDER

This Writ Petition has been filed to direct the respondent to consider the petitioner's representation dated 10.04.2023 and grant permission to the petitioner in order to conduct the cultural program (Adal Padal Nigalchi) which is schedule to be held on 03.05.2023 at 06.00 PM to 11.00 PM in Maariyamman Temple situated at Jayapuram Village & Post, Natrampalli Taluk, Tirupattur District.

Therefore, in view of the detailed circular and guidelines issued by the Director General of Police, the respondent police is hereby directed to consider the representation of the petitioner, dated **10.04.2023** and pass suitable orders based on the above said circular.
