The Writ Petition has been filed to direct the respondent to consider the petitioner's representation dated 05.04.2023 and grant permission to the petitioner in order to conduct the cultural programme (Adal Padal Niglchi) which is scheduled to be held on 04.05.2023 at 06.00 PM to 11.00 PM in Sri Mariamman and Kundi Mariamman Temple Situated at Thonnayanoor Village, Pullaneri Post, Natrampalli Taluk, Tirupattur District.

2.The learned counsel appearing for the petitioner submitted that in order to conduct the cultural programme in the event of Sri Mariamman and Kundi Mariamman Temple Situated at Thonnayanoor Village, Pullaneri Post, Natrampalli Taluk, Tirupattur District on 04.05.2023 between 6 PM to 11 PM, the petitioner has sent a representation dated 05.04.2023 to the respondent. Therefore, in view of the detailed circular and guidelines issued by the Director General of Police, the respondent police is hereby directed to consider the representation of the petitioner, dated 05.04.2023 and pass suitable orders based on the above said circular.

6. With the above direction, this Writ Petition is disposed of. No costs.
