ORDER

This Writ Petition has been filed directing the respondent to grant permission to conduct cultural program (Dance and Music Program) in the ARULMIGU SRI MARIYAMMAN TEMPLE situated at, Colony South Street, Mandakapadi and Post, Sangarapuram Taluk, Kallakurichi District.
