We have heard Mr.P.Saravanan, learned counsel for the petitioner and Mr.B.Vijay, learned counsel for the respondents.

2. The dispute was about the eligibility of the petitioner to appear for the District Judge's examination in the Puducherry Judicial Service.

3. The contention of the petitioner was that he is practicing at Chennai.

4. A Division Bench of this Court under order dated 25.05.2023 permitted the petitioner to appear for the examination to be held on 10.06.2023. Pursuant to the same, the petitioner
