ORDER

The Writ Petition has been filed to direct the respondent to grant permission to conduct cultural program in Sri Arulmigu Mariamman Temple Scheduled to be held on 11.05.2023 at Balajangamanahalli Panchayat, Balajangamanahalli Village, Nallampalli Taluk and Dharmapuri District by considering the petitioner's representation dated 15.04.2023.

2.The learned counsel appearing for the petitioner submitted that in order to conduct the cultural programme in the event of in Sri Arulmigu Mariamman Temple Scheduled to be held on 11.05.2023 at Balajangamanahalli Panchayat, Balajangamanahalli Village, Nallampalli Taluk and Dharmapuri District between 6 PM to 11 PM, the petitioner has sent a representation dated 15.04.2023 to the respondent. Therefore, in view of the detailed circular and guidelines issued by the Director General of Police, the respondent police is hereby directed to consider the representation of the petitioner, dated 15.04.2023 and pass suitable orders based on the above said circular.

6. With the above direction, this Writ Petition is disposed of. No costs.
