2. The grievance ventilated by the Petitioner is that she had made a representation dated 19.01.2023 to the Respondent to pay her terminal benefits, but as it did not evoke any response, she has filed this Writ Petition. The Learned Counsel for the Respondent has also filed a memo dated 24.04.2023 furnishing the current stage of settlement of her terminal benefits as mentioned below:-
