ORDER

This Writ Petition has been filed to direct the respondent to give permission to conduct the cultural programme (Adal padal Nigalchi) in the event of Sri Gangaianman Kovil, Chinnakallupalli, Thirupathur District on 26.04.2023 and 27.04.2023 between 06.00 PM to 11.00 PM based on the petitioner's representation dated 07.03.2023.

Therefore, in view of the detailed circular and guidelines issued by the Director General of Police, the respondent police is hereby directed to consider the representation of the petitioner, dated **07.03.2023** and pass suitable orders based on the above said circular.
