2. The learned counsel appearing for the petitioner submitted that in order to conduct the cultural programme in the event of ***"Sri Mariamman Temple Car Festival" Theppakulakadu Village, Ulipuram Post,***

and 11.00 P.M, the petitioner has sent a representation dated 08.04.2023 to

3. The learned Government Advocate (Crl.side) appearing for the respondent submitted that the respondent police has received the representation of the petitioner and the same is pending for consideration.

Therefore, in view of the detailed circular and guidelines issued by the Director General of Police, the respondent police is hereby directed to
