The Writ Petition has been filed for directing the respondent to give permission and police Protection to conduct cultural programme (Adal Padal

between 06.00 PM to 11.00 PM by considering the petitioners representation dated 11.04.2023.

2.The learned counsel appearing for the petitioner submitted that in order to conduct the cultural programme in the event of Kulikaranpalayam Village Arulmigu Sree Vilayattu Mariamman temple Festival at Bhavani Taluk, Erode District on 27.04.2023 between 6 PM to 11 PM, the petitioner has sent a representation dated 11.04.2023 to the respondent. But, the same has not been considered so far. Hence, the present writ petition has been filed.

3.The learned Government Advocate (Crl.side) appearing for the respondent submitted that the respondent police has received the representation of the petitioner and the same is pending for consideration.

4. I have considered the submission of the learned counsel appearing for the petitioner and the learned Government Advocate (Crl.side) appearing for the respondent police.

5. It is brought to the notice of this Court that the Director General of

Therefore, in view of the detailed circular and guidelines issued by the Director General of Police, the respondent police is hereby directed to consider the representation of the petitioner, dated 11.04.2023 and pass suitable orders based on the above said circular.
