ORDER

This Writ Petition has been filed to direct the respondent to give permission to conduct cultural programme (Adal Padal Nigalchi) in the event of Pakkalam Village Arulmigu Sree Kaliyamman Temple Festival at Gengavalli Taluk, Salem District on 04.05.2023 between 06.00 PM to 11.00 PM by considering the petitioner's representation dated 13.04.2023.
