ORDER

This Writ Petition has been filed to direct the respondent authority to give permission to conduct a cultural program schedule to be held on 05.05.2023 in "Sri Samundeeswari Temple", at about 06.00 PM to 11.00 PM, at Thamalerimuthur Village, Tirupattur Circle, Tirupattur District by considering the petitioner representation dated 13.04.2023.
