ORDER

This Writ Petition has been filed to direct the respondent authority to give permission to conduct cultural programme (Adal Padal) at Salem District, Attur Taluk, Attur Therkukadu, Paithur Road, Kudagu, Sri Samayapurathu Mariyamman Thirukovil Festival on 24.04.2023 by considering the petitioner representation dated 10.04.2023.

The learned counsel appearing for the petitioner submitted that in order to conduct the cultural programme in the event of ***Salem District, Attur Taluk, Attur Therkukadu, Paithur Road, Kudagu, Sri Samayapurathu Mariyamman Thirukovil Festival on 24.04.2023, the petitioner has sent a representation dated 10.04.2023*** to the respondent. But, the same has not been considered so far. Hence, the present writ petition has been filed.

Therefore, in view of the detailed circular and guidelines issued by the Director General of Police, the respondent police is hereby directed to consider the representation of the petitioner, dated **10.04.2023** and pass suitable orders based on the above said circular.
