ORDER

This Writ Petition has been filed to direct the respondent authority to give permission to conduct cultural programme (Adal Padal) at Perambalur District, Veppanthattai Taluk, Poolambadi Village, Sri Mariyamman Thirukovil Festival on 01.05.2023 by considering petitioner representation dated 08.04.2023.
