The Writ Petition has been filed for directing the respondent to give permission and police protection to conduct Cultural programme (Adal

Padal Nigalchi) in the event Musiri, Palpidungipalayam Arulmigu Sree Mariyamman Temple Festival at Tiruchengode Taluk, Namakkal District on 27.04.2023 between 06.00PM to 11.00PM by considering the petitioners representation dated 17.04.2023.

2.The learned counsel appearing for the petitioner submitted that in order to conduct the cultural programme in the event of Musiri, Palpidungipalayam Arulmigu Sree Mariyamman Temple Festival at Tiruchengode Taluk, Namakkal District on 27.04.2023 between 6 PM to 11 PM, the petitioner has sent a representation dated 17.04.2023 to the respondent. But, the same has not been considered so far. Hence, the present writ petition has been filed.

3.The learned Government Advocate (Crl.side) appearing for the respondent submitted that the respondent police has received the representation of the petitioner and the same is pending for consideration.

5. It is brought to the notice of this Court that the Director General of
