The Writ Petition has been filed for directing the first and second respondents to grant permission to conduct the cultural programme of Adal Padal on 25.04.2023 at 06.00PM to 11.00PM at “Sri Bommakkal Temple festival” Kattuvelampalayam Village, A.Erayamangalam Post, Tiruchengode Taluk, Namakkal District by consider and pass orders on the representation dated 14.04.2023 made by the petitioner within the time frame as may be fixed by this Court.

2.The learned counsel appearing for the petitioner submitted that in order to conduct the cultural programme in the event of “Sri Bommakkal Temple festival” Kattuvelampalayam Village, A.Erayamangalam Post, Tiruchengode Taluk, Namakkal District on 25.04.2023 between 6 PM to 11 PM, the petitioner has sent a representation dated 14.04.2023 to the respondent. But, the same has not been considered so far. Hence, the present writ petition has been filed.

3.The learned Government Advocate (Crl.side) appearing for the respondent submitted that the respondent police has received the representation of the petitioner and the same is pending for consideration.
