ORDER

This Writ Petition has been filed to direct the respondent to grant permission to conduct cultural programme (Adal Padal) to be held on 05.05.2023 between 06.00 PM to 11.00 PM in connection with 'Shri Sarvashakthi Mariyamman Temple' festival at Amani Village, Veerappampalayam, Kallangkattuvalasu Post, Kumarapalayam Taluk, Namakkal District by considering the petitioner's representation dated 17.04.2023.

3. The learned Government Advocate (Crl.side) appearing for the respondent submitted that the respondent police has received the representation of the petitioner and the same is pending for consideration.

4. I have considered the submission of the learned counsel appearing for the petitioner and the learned Government Advocate (Crl.side) appearing for the respondent police.

It is brought to the notice of this Court that the Director General of Police, Tamil Nadu, Chennai, had issued a Circular Memorandum in Rc.007301/Genl.I(1)/2019, dated 09.04.2019, along with instructions to the Inspectors of Police throughout Tamil Nadu for consideration of applications seeking permission for conducting cultural programme. Therefore, in view of the detailed circular and guidelines issued by the Director General of Police, the respondent police is hereby directed to consider the representation of the petitioner, dated **17.04.2023** and pass suitable orders based on the above said circular.
