ORDER

This Writ Petition has been filed to direct the respondent to give permission and police protection to conduct cultural programme (Adal Padal Nigalchi) in the event of Pallathanur Village Arulmigu Sree Thottiyathu Mariyamman Temple Festival at Valapadi Taluk, Salem District on 03.05.2023 between 06.00 PM to 11.00 PM by considering the petitioner's representation dated 13.04.2023.
