ORDER

This Writ Petition has been filed to direct the respondent to grant permission and police protection to conduct cultural event viz., Adal Padal (Song and Dance) program to be held on 06.05.2023 at 06.00 PM onwards in connection with the Temple Festival of Arulmigu Sri Om Sakthi Mariamman Temple, Lee Bazar Main Road, Arisipalaiyam Area, Salem City and District by considering the petitioner's representation dated 17.04.2023.

The learned counsel appearing for the petitioner submitted that in order to conduct the cultural programme in the event of *Arulmigu Sri Om Sakthi Mariamman Temple, Lee Bazar Main Road, Arisipalaiyam Area, Salem City and District on 06.05.2023 at 06.00 P.M onwards, the petitioner has sent a representation dated 17.04.2023* to the respondent. Therefore, in view of the detailed circular and guidelines issued by the Director General of Police, the respondent police is hereby directed to consider the representation of the petitioner, dated **17.04.2023** and pass suitable orders based on the above said circular.
