ORDER

This Writ Petition has been filed to direct the respondent to grant permission and police protection to conduct the cultural event viz., Adal Padal (Song and Dance) program to be held on 05.05.2023 at 06.00 PM onwards in connection with the Temple Festival of Arulmigu Sri Vada Pathra Kaliyamman Temple, Nallan Pillai Petran Village, Kalasapakkam Taluk, Thiruvannamalai District by considering the petitioner's representation dated 16.04.2023.

The learned counsel appearing for the petitioner submitted that in order to conduct the cultural programme in the event of *Arulmigu Sri Vada Pathra Kaliyamman Temple, Nallan Pillai Petran Village, Kalasapakkam Taluk, Thiruvannamalai District on 05.05.2023 at 06.00 P.M onwards, the petitioner has sent a representation dated 16.04.2023* to the respondent.

It is brought to the notice of this Court that the Director General of Police, Tamil Nadu, Chennai, had issued a Circular Memorandum in Rc.007301/Genl.I(1)/2019, dated 09.04.2019, along with instructions to the Inspectors of Police throughout Tamil Nadu for consideration of applications seeking permission for conducting cultural programme. Therefore, in view of the detailed circular and guidelines issued by the Director General of Police, the respondent police is hereby directed to consider the representation of the petitioner, dated **16.04.2023** and pass suitable orders based on the above said circular.
