ORDER

This Writ Petition has been filed to direct the first and second respondents to grant permission to conduct the cultural programme of Adal Padal on 30.04.2023 at 06.00 PM to 11.00 PM at "Sri Mariamman Temple Festival" Pudur Kallanguthur, Hasthampatti Post, Salem Taluk, Salem District by consider and pass orders on the representation dated 15.04.2023 made by the petitioner within the time frame as may be fixed by this Hon'ble Court.

The learned counsel appearing for the petitioner submitted that in order to conduct the cultural programme in the event of "***Sri Mariamman Temple Festival***" Pudur Kallanguthur, Hasthampatti Post, Salem Taluk, Salem District on 30.04.2023 between 06.00 P.M and 11.00 P.M, the petitioner has sent a representation dated 15.04.2023 to the respondent.

It is brought to the notice of this Court that the Director General of Police, Tamil Nadu, Chennai, had issued a Circular Memorandum in Rc.007301/Genl.I(1)/2019, dated 09.04.2019, along with instructions to the Inspectors of Police throughout Tamil Nadu for consideration of applications seeking permission for conducting cultural programme. Therefore, in view of the detailed circular and guidelines issued by the Director General of Police, the respondent police is hereby directed to consider the representation of the petitioner, dated **15.04.2023** and pass suitable orders based on the above said circular.
