This Writ Petition has been filed for the issuance of Writ of Mandamus, directing the first respondent to issue a No Objection Certificate to the petitioner to run a SPA i.e. cross relaxation massage in the name and style of "SMS SALOON & SPA" at Door No.10/639-D, Kunnangal Palayam Pirivu, Palladam Road, Tirupur District, Pin 641 604, by passing orders on the petitioner's representation dated 11.04.2023.

It is the contention of the learned counsel for the petitioner that the petitioner is running a SPA i.e. cross relaxation massage in the name and style of "SMS SALOON & SPA" at Door No.10/639-D, Kunnangal Palayam Pirivu, Palladam Road, Tirupur District, Pin 641 604. He would further submit that the petitioner has made a representation dated 11.04.2023 to the first respondent seeking for the issuance of "No Objection Certificate" to run the said business and the same is not considered by the respondents. Hence this petition.

3. The learned Government Advocate (Crl.Side), appearing for the respondents submitted that the respondent police has received the representation of
