In all these Writ Petitions, the challenge was made to some of the key answers for the Tamil Nadu Teacher's Eligibility Test for paper 1 and 2 for the year 2022.

2.Today, when the matter was called, the learned Additional Advocate General, submitted that after the release of the final key answers till April 2023, 84 objections were received against the final answers. Hence, Board has constituted Subject Expert committee for re-evaluating all these key answers. Accordingly, the marks were awarded for the wrong key answers and all the petitioners herein have been declared to have passed the test and certificates were also issued.
