WEB COPY This Writ Petition has been filed for the issuance of Writ of Mandamus, directing the first respondent to issue a No Objection Certificate to the petitioner to run a SPA i.e. cross relaxation massage in the name and style of "SHARA AYURVEDIC & BEAUTY SPA", at Door No.465, Selvapuram, Perur MainRoad, Coimbatore, Coimbatore District, Pin 641 001, by passing orders on the petitioner's representation dated 11.04.2023.

2.It is the contention of the learned counsel for the petitioner that the petitioner is running a SPA i.e. cross relaxation massage in the name and style of "SHARA AYURVEDIC & BEAUTY SPA", at Door No.465, Selvapuram, Perur MainRoad, Coimbatore, Coimbatore District, Pin 641 001. He would further submit that the petitioner has made a representation dated 11.04.2023 to the respondents seeking for the issuance of "No Objection Certificate" to run the said business and the same is not considered by the respondents. Hence this petition.
