ORDER

This Writ Petition has been filed to direct the respondent to grant permission to conduct cultural program in Arulmigu Sri Muthu Mariamman Temple scheduled to be held on 31.05.2023 at Adhiyamman Kottai Panchayat, Elagiriyankottai Village, Nallampalli Taluk and Dharmapuri District.

The learned counsel appearing for the petitioner submitted that in order to conduct the cultural programme in the event of ***Adhiyamman Kottai Panchayat, Elagiriyankottai Village, Nallampalli Taluk and Dharmapuri District on 31.05.2023, the petitioner has sent a representation dated 18.04.2023*** to the respondent. Therefore, in view of the detailed circular and guidelines issued by the Director General of Police, the respondent police is hereby directed to consider the representation of the petitioner, dated **18.04.2023** and pass suitable orders based on the above said circular.
