ORDER

This Writ Petition has been filed to direct the respondent to give permission to conduct cultural programme (Adal Padal Nigalchi) in the event of Dhasara Halli Village, Ambedkar Nagar Arulmigu Sree Mariyamman & Kaliyamman Temple Festival at Harur Taluk, Dharmapuri District on 27.04.2023 between 06.00 PM to 11.00 PM by considering the petitioner's representation dated 15.04.2023.
