ORDER

This Writ Petition has been filed to direct the respondent to give permission to conduct cultural programme (Adal Padal Nigalchi) in the event of Kollapatti Village Arulmigu Sree Ellammal & Bothurajulu Swamy Temple Festival at Tiruchengode Taluk, Namakkal District on 05.05.2023 between 06.00 PM to 11.00 PM by considering the petitioner's representation dated 15.04.2023.

Therefore, in view of the detailed circular and guidelines issued by the Director General of Police, the respondent police is hereby directed to consider the representation of the petitioner, dated **15.04.2023** and pass suitable orders based on the above said circular.
