ORDER

This Writ Petition has been filed to direct the respondent to give permission to conduct cultural programme (Adal Padal Nigalchi) in the event of Malaikkadu, Rajaganapathi Nagar Arulmigu Sree Rajaganapathi & Devi Karumariyamman Temple Festival at Kumarapalayam Taluk, Namakkal District on 27.04.2023 between 06.00 PM to 11.00 PM by considering the petitioner's representation dated 15.04.2023.

It is brought to the notice of this Court that the Director General of Police, Tamil Nadu, Chennai, had issued a Circular Memorandum in Rc.007301/Genl.I(1)/2019, dated 09.04.2019, along with instructions to the Inspectors of Police throughout Tamil Nadu for consideration of applications seeking permission for conducting cultural programme. Therefore, in view of the detailed circular and guidelines issued by the Director General of Police, the respondent police is hereby directed to consider the representation of the petitioner, dated **15.04.2023** and pass suitable orders based on the above said circular.
