ORDER

This Writ Petition has been filed to direct the respondent authority to give permission to conduct a cultural program schedule to be held on 03.05.2023 in "Sri Selva Maariamman Temple", at about 06.00 PM to 11.00 PM, at Anuppur Village, Vazhapadi Taluk, Salem District by considering the petitioner representation dated 18.04.2023.

Therefore, in view of the detailed circular and guidelines issued by the Director General of Police, the respondent police is hereby directed to consider the representation of the petitioner, dated **18.04.2023** and pass suitable orders based on the above said circular.
