ORDER

2. The learned counsel appearing for the petitioner submitted that though the respondent police has registered a case in Crime No. 62 of 2021 no final report has been filed till date. Hence, the present petition has been filed.

3. The learned Government Advocate (Criminal Side) appearing for the respondent would submit that, based on the complaint lodged by the petitioner, the respondent police has registered the FIR in Crime No.62 of 2021 , in which, investigation is under progress.
