ORDER

[Order of the Court was made by C.V.KARTHIKEYAN, J.,]

- (1) The detainee, a minor, aged 17 years had been secured and we had the benefit of interacting with her. She stated that she did not like the place of work and therefore, had voluntarily moved away.
- (2) Her mother is also present. She is the petitioner herein. It would only be appropriate that the custody of the detainee is handed over to her mother and the mother had also taken her in custody.
- (3) We would also feel it appropriate that directions are given to District Legal Services Authority, Kallakurichi, to interact with the petitioner and with the detainee and find out whether it is possible to give some employment to the detainee or at least, give some focus to her life so that she could move forward and not indulge herself in such activities of which she is complained of.
