ORDER

This Writ Petition has been filed to direct the respondent authority to give Bandhobasth and permission for conducting the cultural dance program (Adal Padal) in the event of Perumapalayam Village Mari Amman Thirukovil at Perumapalayam Village, Jambai, Bhavani, Erode District on 03.05.2023 between 06.00 PM to 11.00 PM based on petitioner's representation dated 19.04.2023.
