ORDER

This Writ Petition has been filed to direct the respondent to give permission and police protection to conduct cultural programme (Adal Padal Nigalchi) in the event of Thiruvottiyur, Thiyagi Sathiyamoorthi Nagar Arulmigu Sree Muneeswarar & Vettudayal Kaliyamman Temple Festival at Thiruvottiyur Taluk, Thiruvallur District on 30.04.2023 between 06.00 PM to 11.00 PM by considering the petitioner's representation dated 18.04.2023.
