ORDER

The petitioner has filed this writ petition seeking issuance of a writ of mandamus directing the third respondent to dispose of the petitioner's representation dated 09.01.2023 to cancel the appointment of the fifth respondent as trustee and to remove the lock from the doors of Manickavasaga Swami Madam at Poondi Village, Thiruvannamalai District.

2. Learned counsel for the petitioner submitted that ends of justice would be met if the third respondent is directed to consider the representation of the petitioner dated 9.1.2023 within a stipulated time.

3. Mr.S.Yashwanth, learned Additional Government Pleader appearing on behalf of respondents 2 to 4, submitted that, if six weeks' time is granted, the third respondent will consider the representation of the petitioner dated 9.1.2023 and pass appropriate orders in accordance with law.
