This case came up for settlement before the Lok Adalat. Both parties are present. M/s.V.Ramya V.Rao, the learned counsel for the respondents and Mr.T.Chandrasekaran, the learned counsel for the appellants are present. After mutual discussion, negotiation, mediation and conciliation between both parties, they arrived at a compromise to settle the matter as follows:

**TERMS OF SETTLEMENT**

The Tribunal has awarded a sum of Rs.17,16,500/- with interest at 7.5% per annum from the date of filing of the petition till the date of deposit with cost. Aggrieved by the award of the Tribunal, the appellant had preferred the present appeal.

2. After due deliberation and consultation, both the parties have agreed to settle the case for a sum of Rs.24,75,000/- (Rupees Twenty Four Lakhs Seventy Five Thousand Only) in full quit.

3. The appellant shall deposit the award amount less the amount already deposited, if any, within a period of twelve weeks from the date of receipt of a copy of this order. On such deposit being made, the claimants / respondents 1, 4 & 5 are permitted to withdraw their respective share of the award amount without insisting on a formal payment out petition. The share of the minor/respondents 2 and 3 are directed to be deposited in any one of the Nationalised Banks till they attain majority. The first respondent/mother of the minor respondents 2 and 3 is permitted to withdraw the accrued interest once in a period of three months for the welfare of the minors. Award is modified accordingly.

4. The Tribunal is directed to transfer the amount through RTGS/NEFT to the parties concerned on proper identification in accordance



with the terms of the award, as per the apportionment already made by the Tribunal. Consequently, the connected miscellaneous petition, if any, is closed.

5. This Civil Miscellaneous Appeal is disposed of accordingly.
