ORDER

This Writ Petition has been filed to direct the respondent to consider the petitioner's representation dated 24.04.2023 and grant permission to the petitioner in order to conduct the cultural program (Adal Padal Nigalchi) which is schedule to be held on 05.05.2023 at 06.00 PM to 11.00 PM in Sri Maariyamman Temple situated at Kethandapatti, Chinna Koothandavar Kuppam, Tirupattur District.

Therefore, in view of the detailed circular and guidelines issued by the Director General of Police, the respondent police is hereby directed to consider the representation of the petitioner, dated **24.04.2023** and pass suitable orders based on the above said circular.
