2. The case of the petitioner is that the petitioner herein is the first defendant and the first respondent herein is the plaintiff. The first respondent filed a suit in O.S.No.294 of 2014 on the file of the Principal District Court, Chengalpattu for partition in respect of the suit property.

The learned counsel for the petitioner submitted that after filing of the written statement there is no further progress in the above suit for the past nine years and now the petitioner is about 70 years old senior citizen and he is suffering from serious health issues but unable to take better treatment because of want of money. Due to the pending litigation, he is unable to mobilize the fund for treatment. Therefore, the petitioner has filed the present civil revision petition for a direction to the learned Principal District Judge, Chengalpattu to dispose of the suit in O.S.No.294 of 2014 within the stipulated time that may be fixed by this Court.
