ORDER

The petitioner alleging that his property is induced by the trespasser is seeking police protection to fence the land, while measuring the property.

2.The Court order cannot be used as a tool to evade the occupant without following due process of law. In case, if the petitioner wants to measure his land and demark the boundary, it is always open to him to make an appropriate application under the Tamil Nadu Survey and Boundaries Act

and in the course of survey, if any police protection is required, it is for the surveyor to seek assistance from the police.

3. Accordingly, Criminal Original Petition is dismissed.
