ORDER

This Writ Petition has been filed to direct the respondent to give permission to conduct cultural programme (Adal Padal Nigalchi) in the event of T.Eanthal Village Arulmigu Sree Selliyamman Temple Festival at Thittakkudi Taluk, Cuddalore District on 30.04.2023 between 06.00 PM to 11.00 PM by considering the petitioner's representation dated 20.04.2023.
