This Writ Petition has been filed directing the respondent to grant permission to conduct the cultural programme of Adal Padal on 11.05.2023 at “Nanjundapuram Village Arulmigu Sri Maha Mariamman Kovil Thiruvizha” by considering the petitioner's representation dated 24.04.2023.

Therefore, in view of the detailed circular and guidelines issued by the Director General of Police, the respondent police is hereby directed to consider the representation of the petitioner, dated 24.04.2023 and pass suitable orders based on the above said circular.

6. With the above direction, this Writ Petition is disposed of. No costs.
