ORDER

This Writ Petition has been filed to direct the respondent to give for permission to conduct the cultural programme (Adal Padal Nigalchi) in the event of Sri Bagavathiamman Kovil at Old Mettur, Chinnathambi Pazhayam, Anthiyur, Erode District on 05.05.2023 between 06.00 PM to 11.00 PM based on the petitioner's representation dated 07.04.2023.
