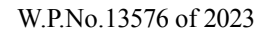

PRAYER: Writ Petition is filed under Article 226 of Constitution of India, pleaded to issue a Writ of Mandamus, directing the respondent to give for permission to conduct the cultural programme (Adal Padal Nigalchi) in the event of Arulmighu Madhuraiveeran at Chinnameedu, Pudhucolony, Kathirampatti Village, Erode District on 05.05.2023 between 06.00 PM to 11.00 PM based on the petitioner's representation dated 07.04.2023.

ORDER

The learned counsel appearing for the petitioner submitted that in order to conduct the cultural programme in the event of *Arulmighu Madhuraiveeran at Chinnamedu, Pudhucolony, Kathirampatti Village, Erode District on 05.05.2023 between 06.00 P.M and 11.00 P.M, the petitioner has sent a representation dated 07.04.2023* to the respondent. But, the same has not been considered so far. Hence, the present writ petition has been filed.

Therefore, in view of the detailed circular and guidelines issued by the Director General of Police, the respondent police is hereby directed to consider the representation of the petitioner, dated **07.04.2023** and pass suitable orders based on the above said circular.
