ORDER

This Writ Petition has been filed to direct the respondent to give permission and police protection to conduct the cultural event viz., Adal Padal Nigalzhi program to be held on 31.05.2023 at 06.00 P.M onwards in connection with the Temple Festival of Sri Kongalamman Thirukovil, Nallagoundampalayam, Pillikalpalayam, Paramathi Velur T.K, Namakkal District by considering representation dated 24.04.2023.

Therefore, in view of the detailed circular and guidelines issued by the Director General of Police, the respondent police is hereby directed to consider the representation of the petitioner, dated **24.04.2023** and pass suitable orders based on the above said circular.
