ORDER

This Writ Petition has been filed to direct the respondent authority to give permission to conduct cultural programme (Adal Padal) at Salem District, Attur Taluk, Attur Town, Kottai, Sri Muniyappan Thirukovil Festival on 26.05.2023 by considering petitioner representation dated 20.04.2023.

The learned counsel appearing for the petitioner submitted that in order to conduct the cultural programme in the event of ***Salem District, Attur Taluk, Attur Town, Kottai, Sri Muniyappan Thirukovil Festival on 26.05.2023, the petitioner has sent a representation dated 20.04.2023*** to the respondent. But, the same has not been considered so far. Hence, the present writ petition has been filed.

Therefore, in view of the detailed circular and guidelines issued by the Director General of Police, the respondent police is hereby directed to consider the representation of the petitioner, dated **20.04.2023** and pass suitable orders based on the above said circular.

6. With the above direction, this Writ Petition is disposed of. No costs.
